Sub.: Violation of provisions of Mineral Conservation and Development Rules, 2017, in respect to Rodada Limestone Mine (13.150 hectare) Mine Code 38MPR12080 in District Dhar of Madhya Pradesh State.

Sir,

Undersigned has inspected your subject mine in the presence of Shri V.K Chankunday, DGM (Mines) and Shri Siyaram Mishra (Geologist) on 18/02/2023. Following provisions of MCDR 2017 were found violated in said mine at the time of inspection.

Rule No	Nature of violation observed in detail
Rule 11(1)	<p><i>No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section (2) of section 5</i></p> <p>(a) During the year 2021-22, only 30,050 Tonnes of Limestone was produced against the proposed production 1,00,006 Tonnes which accounts 70% of deviation in the proposal justify the same, as it will distort the yearly proposal approved in the mining plan.</p>

1. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.
2. The mining operations can be suspended under the rule 11(2) of MCDR-2017, if compliance of rule 11(1) of MCDR-2017 is not found satisfactory.
3. You are advised to rectify the violations of abovementioned rules immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
