Subject:-Violation of provisions of Mineral Conservation and Development Rules, 2017, in Ramrama Manganese Mine, over an area of 43.086 hectare, situated in village-Ramrama , Tehsil- waraseoni District-Balaghat of M.P. State.

Sir,

Undersigned has inspected your mine in the presence of your representative Shri V.A Borkar, (Agent), MR. M.K. Choudhary (Mine Manager) and other mines officials on 10/06/2023. The document of above mentioned mine was approved vide letter No.-MP/Balaghat/Manganese/MPLN/MOD-32/2019-20 dated 16/06/2020 incorporating proposal of working from 2020-21 to 2024-25. Following provisions of MCDR 2017 were found violated in your mines at the time of inspection.

11(1)of MCDR 2017	<p>Mining operations under mining lease.–(1) No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section (2) of section 5</p> <ol style="list-style-type: none"> 1. It was proposed to produce 57131 Tonnes of Manganese but 44015 Tonnes production was done. 2. Height of benches is not maintained as per approved document. 3. Dumping has been done outside the lease between B.P 50 to 51, 53 to 54 and 57 to 59.

1. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.
2. The mining operations can be suspended under the rule 11(2) of MCDR-2017, if compliance of rule 11(1) of MCDR-2017 is not found satisfactory.
3. You are advised to rectify the violations of above mentioned rules immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
