Subject: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your **Bhadanpur Limestone Mine, (663 Hect.)** Mine code 38MPR35274 in **Satna** district of **M.P. State**.

Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mentioned mine during inspection on 14/07/2023 by the undersigned in presence of Shri P K Upadhyay, Agent (Mines), Shri Saurav Jain, Geologist:

नियम स.	पाए गए उल्लंघन की विस्तृत प्रकृति
Rule 11 (1)	<p>According to this rule-No holder of a mining lease shall commence or carry out mining operation in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines. The Modification of Mining Plan of afore mentioned mine was approved vide this office letter No-MP/SATNA/LIMESTONE/RMP-45/2021-22 dated 15.11.2021 incorporating the proposals of working from 2022-23 to 2026-27. During the inspection, it was found that following provisions of the rule have been violated during the year 2022-23:-</p> <ol style="list-style-type: none"> 1. Only 10534 M³ top soil removed against the proposal of 36572 M³. 2. Only 188965 M³ over Burden removed against the proposal of 247816 M³. 3. Only 1972918 tons limestone production achieved against the proposal of 2199669 tons. <p>The mine development was lagging from the approved proposal.</p> <ol style="list-style-type: none"> 4. Lesser area is backfilled against the proposal.

02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR-2017.
03. Non-compliance of the rule 11(1) of MCDR-2017 may lead to suspension of Mining operations under the provisions of rule 11(2) of MCDR-2017.
04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
