The following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection carried out by the undersigned along with Shri. H.M.Shivakumar-Assistant Mining Engineer in presence of Shri. J. Srikanth Manager (Mines) & Shri. Rashmin Ranjan Sahu -Geologist on **05/07/2023.**

	RMP with PMCP was approved vide letter No. 279/419/94/BNG dated 03/01/2022 for the period from 2022-2023 to 2026-2027. The deviations observed in mining operations vis-a-vis approved document are given below:

	(i) It was proposed to carry out mining with a total excavation 16.03 Ha and dumping over an extent over 7.88 Ha for the year 2022-2023 During the inspection it is observed that at some places i.e., between sections P-P' & R-R' excavations are extending beyond the approved grid intervals thereby excavation totaling over 16.27 Ha and dumping over 8.37 Ha. respectively thereby deviating from the proposed extents.
	(ii) During the year 2022-2023, It was proposed to carry out exploration by drilling 6 Core Boreholes. However, exploration is carried out by 16 DTH Boreholes in place of Core drilling proposal.

02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017 read with MCDR (Amendment) Rule, 2021.
