

Subject: Violation of provisions of MCDR 2017 read with MCDR(Amendment), 2021 in respect of your Doddabyladakere Iron & Mn ore mine (ML No. 2639) over an extent of 40.07Ha located in Doddabyladakere Village, Chitradurga District of Karnataka State.

## महोदय/Sir.

The following provisions of the Mining Conservation and Development Rules, 2017 read with Mining Conservation and Development (Amendment) Rules, 2021 were found violated in your mine during the inspection carried out on 26/07/2023 by undersigned alongwith Shri H.M. Shivakumar, AME in presence of Sri. Ishwar N Kolar - Mines Manager, Sri. B. Shankar - Mining Engineer and Sri. M. Mohan- Geologist.

Rules	Nature of Violations observed
45(7)	In the Annual Return submitted for the year 2022-23, following discrepancies were observed
	i. In PART-III (2)(4), Depreciation on fixed assets given as 'zero', however, in Part-II A Depreciation of plant, machinery etc shown as Rs. 168418.
	ii. In PART-V (General Geology & Mining) (1)(i) Exploration activities carried out during the year shown as 54 no. of pits and 5 no. of trenches with total excavation of 5400 m3 and 764 m3 respectively, however, no pitting & trenching carried out during the year 2022-23.
	iii. In PART-V (General Geology & Mining) (3) Subgrade-Mineral Reject of Iron ore generated/stacked during the year given as 4000 tons, which is not tallying with the depletion of Reserves shown during the year in para PART-V (2) and Grade-wise Production given in PART-VI (3)(ii).
	iv. In PART-VI (3)(ii) Ex-mine price given is incorrect and not tallying with the sale value given in PART-VI (5) – sales-dispatches.

  - 03. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR (Amendment), 2021.
  - 04. You are therefore directed to show cause within a period of **thirty (30) days** from the date of issue of this notice, as to why action under subrue (7) of Rule 45 of and Rule 62 of MCDR (Amendment), 2021 shall not be taken against you.
  - 05. You are advised to rectify the above violations immediately and intimate the position to this office **within 30 (thirty) days** from the date of issue of this notice.
