Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Budgauna Limestone Mine over an extent of 60.671 hectares in Budgauna village, Rampur Naikin Taluka, in Sidhi District of Madhya Pradesh state.

Sir,

The undersigned inspected your mine on 06/07/2023 in the presence of your representative Shri Bharat Gokharu (Mines Agent), Shri Modi Yakin Rajesh Kumar (Mines Manager), Sanjeev Agnihotri (Geologist) other mines officials. The document of above mentioned mine was approved vide letter No. MP/Sidhi/Limestone/RMP-48/2021-22 dated 24.11.2021 incorporating proposal of working from 2022-23 to 2026-27. The following provisions of MCDR 2017 were found violated in your mines at the time of inspection.

It has been observed during the inspection that in the annual return submitted for the year 2022-23, the exploration details have not been furnished in Part V and Exploration cost has not been considered in Part VII in the cost of production per tonne of mineral produced.

- 02. In this connection, it is brought to your notice that the above violations constitute an offense punishable under rule 62 of Mineral Conservation and Development Rules, 2017.
- 03. Non-compliance with the rule 11(1) and 45(7) of MCDR, 2017 may lead to the suspension of mining operations under the provisions of rules 11(2) & 45(7)(a)(i) of Mineral Conservation and Development Rules, 2017.
- 04. You are therefore advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
