विषय : Violation of provisions of MCDR, 2017 in respect of your JSW Limestone Mine over an extent of 617.57 Ha. situated in Villages Bilakalagudur and Bujanuru, Mandal Gadivemula, District Kurnool of Andhra Pradesh State.

महोदय / महोदया,

The following provisions of Mineral Conservation and Development Rules, 2017 (MCDR, 2017) were found violated in the above mine during the inspection on 10/08/2023 by the undersigned in presence of the mine officials Shri Sachin Tonge, Dy. General Manager (Mines).

Rule 11 (1)	<p>No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section (2) of section 5 or approved by the competent authority of the Atomic Minerals Directorate for Exploration and Research, in respect of minerals specified in Part B of the First Schedule to the Act where the grade of such atomic minerals is equal to or above the threshold value limits declared under Schedule-A of the Atomic Minerals Concession Rules, 2016.</p> <p><i>The following deviations have been found in the mine from the approved Review of Mining Plan vide letter no. AP/KNL/MP/Lst.-126/Hyd. Hyderabad dated 27/11/2017 for the period of F.Y. 2018-19 to 2022-23.</i></p> <p>Production & Development: <i>During F.Y. 2022-23; it was proposed to carry out the production and development in between UTM Co-ordinates N1734471 to N1735720 and E225949 to E225932, whereas, production and development has been done in between UTM co-ordinates N1734376 to N1735904 and E225960 to E227220.</i></p> <p>Waste/Overburden Generation: <i>During F.Y. 2022-23; 193365.42 CuM of waste/overburden has been generated without any approved proposal.</i></p> <p>Topsoil Generation: <i>During F.Y. 2022-23; 1158.49 CuM of topsoil has been generated without any approved proposal.</i></p>

Rule No.	Nature of violation
Rule 11 (1)	Mineral Reject Generation: During F.Y. 2022-23, it was proposed to generate 7320.0 Tonnes of mineral-reject, whereas, NIL mineral reject has been generated. Protective Measures: No protective measures have been taken around two numbers of old abandoned quarries situated either side of the road in between UTM co-ordinates N1374044 to N1734416 and E225432 to E225788

02. In this connection, it is brought to your notice that the violation of aforesaid rule constitutes an offence, punishable under Rule 62(1) of MCDR, 2017.

03. The mining operations and dispatches can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
