विषय : Violation of provisions of MCDR, 2017 in respect of your Tummlapenta-2 Limestone Mine over an extent of 114.372 Ha. situated in Village Tummalapenta, Mandal Kolimigundla, District Kurnool of Andhra Pradesh State.

महोदय / महोदया,

The following provisions of Mineral Conservation and Development Rules, 2017 (MCDR, 2017) were found violated in the above mine during the inspection on 23/08/2023 by the undersigned in presence of the mine officials Shri K. Naga Sidda Reddy, Agent (Mines).

Rule No.	Nature of violation
Rule 11 (1)	<p>No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section (2) of section 5 or approved by the competent authority of the Atomic Minerals Directorate for Exploration and Research, in respect of minerals specified in Part B of the First Schedule to the Act where the grade of such atomic minerals is equal to or above the threshold value limits declared under Schedule-A of the Atomic Minerals Concession Rules, 2016.</p> <p><i>The following deviations have been found in the mine from the approved Modified Mining Plan vide letter no. AP/KNL/MP/Lst.-130/Hyd. Hyderabad dated 26/02/2021 for the period of F.Y. 2021-22 to 2025-26.</i></p> <p><b>Production &amp; Development:</b> <i>During F.Y. 2022-23; it was proposed to carry out the production and development in between UTM Co-ordinates N1664300 to N1664390 and E181900 to E182010, whereas, production and development has been done in between UTM co-ordinates N1664440 to N1664580 and E181850 to E181925.</i></p> <p><b>Stacking of Mineral/Ore:</b> <i>Certain quantity of the mineral/ore has been kept in between UTM Co-ordinates N1664500 to N1665500 and E181500 to E182500 without any approved proposal.</i></p>

Rule No.	Nature of violation
Rule 11 (1)	<b>Protective Measures:</b> <i>No protective measures have been taken around the several numbers of old abandoned quarries situated in between UTM co-ordinates N1664000 to N1666000 and E181000 to E182500.</i>
Rule 19 (1)	<b>Machinery and Plant:</b> (1) Where heavy earth moving machinery is used in mines, the holder of a mining lease shall maintain log books duly authenticated by the manager or mining engineer of such mines in respect of each machine showing date-wise account of hours worked, hours not worked, reasons for non-working, consumption of fuel or energy and lubricants and output of the machine during the corresponding working hours.  <i>Logbooks of the machineries deployed in the mining operations have not been maintained.</i>

02. In this connection, it is brought to your notice that the violation of aforesaid rule constitutes an offence, punishable under Rule 62(1) of MCDR, 2017 as well as Fine may be imposed as specified under Schedule-III of rule 62(2) of MCDR, 2017 Amended up to 3rd November 2021.

03. The mining operations and dispatches can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
