महोदय / Sir,

On examination of the office records, following provisions of the MCDR-2017 were found violated in your said mine;

Rule NoNature of violation observed in detail

Rule 45(5)(b) The holder of a mineral concession shall submit online returns in respect of each mine to the Regional Controller and the authorised officer of the Indian Bureau of Mines in the following manner, namely:

(b) a monthly return which shall be submitted before the tenth day of every month in respect of the preceding month in electronic form along with a signed print copy of the same if it is not digitally signed, in the respective form.

On examination of the office records it is found that you were delayed to file online monthly return as per rule 45(5)(b) of MCDR-2017.

- 1. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.
- 2. Failure to undertake rectification action for the above violation as per rule 45(7A) (ii)(a) of MCDR'2017 within 30 days by paying an amount at the rate of Rs.10,000 per day as per Schedule II of MCDR' 2017 (amended on 3rd November 2021) after due date of submission is liable for action as per provisions mentioned under 45(7)(A)(ii)(b) by suspension, prosecution and / or may be recommended for termination.
- 3. You are advised to rectify the above violations immediately and intimate to this office within 30 (Thirty) days from the date of issue of this letter.
