Sub.: Violation of provisions of Mineral Conservation and Development Rules, 2017, in respect to Ramastan Limestone Mine ( 7.28 ha ), Mine Code - 38 MPR35120 DisttSatna (M.P).
Sir,
The following provision of Mineral Conservation and Development Rules 2017 were found violated in your above mentioned mine during the inspection by the undersigned on 07/07/2023 in presence of you.

| Rule 11(1) | No holder of a mining lease shall commence or carry out mining operations in any <br> area except in accordance with the mining plan approved, modified or reviewed by <br> the Indian Bureau of Mines or prepared and certified in accordance with the system <br> established by the State Government pursuant to the proviso to clause (b) of sub- <br> section (2) of section 5. <br> (i) $\quad$Only 43450 T of Limestone produced during the 2022-23 against the proposed <br> 99,990T which is distorting the proposals approved by 56.54\%. <br> Rule 34A $\quad$Waste dump on the northern and north eastern side encroached the lease <br> boundary. <br> Every lessee shall carry out a drone survey of his leased area and upto hundred metres <br> outside the lease boundary within six months before submission of any mining plan <br> document or modification thereto to the Indian Bureau of Mines for approval and shall <br> submit processed output [digital elevation model (DEM) and Orthomosaic] images <br> obtained from such survey or any other format as may be specified by the Indian Bureau <br> of Mines in this regard to the concerned Regional Controller of Mines and the <br> Controller General along with the application for approval or modification of mining <br> plan. <br> The required Drone survey data has not been submitted as per the Standard <br> Operating Procedure for carrying out Drone Survey and submission of digital images <br> issued by Indian Bureau of Mines. |

1. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.
2. The mining operations can be suspended under the rule 11(2) of MCDR-2017, if compliance of rule 11(1) of MCDR-2017 is not found satisfactory.
3. You are advised to rectify the violations of above mentioned rules immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
