विषय Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Gujarat Ambuja Limestone & Marl Mine over an area of 108.97 ha located near Villages-Vadnagar, Tehsil-Kodinar, District-Gir-Somnath in Gujarat.

महोदय Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 (MCDR, 2017) were found violated in your above mine during the MCDR inspection made by the undersigned on 11.11.2022 AN in the presence of Shri Praveen Singh, Mine Manager & Shri AK Jain, DGM.

RULE NO.	NATURE OF VIOLATION OBSERVED
11(1)	<b>The mining operations were not being carried out as proposed in approved Modified Mining Plan vide 684(4) (1) MP-335(252)/2021-खानिखस(उ)/GNR Dated 16.8.2021.</b> <u>Plantation</u> -It was proposed to work in 2021-22 as earmarked/proposed at page no 47 i.e. afforestation of 0.2Ha area & 200 No of plants and Bella stone wall of 40m & barbed wire fencing of 100m but during inspection no such protective work observed & carried out.
55(1)(3)(i)	A Geologist has not been appointed for the purpose of carrying out mining operations in accordance with these rules.

- In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
- Mining operations can be suspended as per rule 11(2) in case of non-compliance of rule 11(1), as these rules ensures systematic scientific and responsible mining and/or state Government may be informed to take actions as per competent directives.
- This letter has been issued with the approval of Regional Controller of Mines.
- You are advised to rectify the above violation immediately and intimate the compliance position to this office, within 45 days from date of issue of this letter.
