	<u>Plantation</u> -It was proposed to work in 2021-22 as earmarked/proposed at page no 62 i.e. 2Ha area & 3000 No of plants and Bella stone wall of 300m & barbed wire fencing of 1500m but during inspection no such protective work observed & carried out and part of lease area, backfilled by topsoil for agro farm/pasture land but no proposal was there.

- 2. In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
- 3. Mining operations can be suspended as per rule 11(2) in case of non-compliance of rule 11(1), as these rules ensures systematic scientific and responsible mining and/or state Government may be informed to take actions as per competent directives.
- 4. You are advised to rectify the above violation immediately and intimate the compliance position to this office, within 45 days from date of issue of this letter.
