विषय Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Chhelana Bauxite Mine over an area of 12.67 ha located near Village-Chhelana, Tehsil-Jafrabad, District-Amreli in Gujarat.

महोदय Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 (MCDR, 2017) were found violated in your above mine during MCDR inspection made by the undersigned on 14.11.2022 FN in the presence of Sh. Anil Prajapat, Lessee rep.

RULE NO.	NATURE OF VIOLATION OBSERVED
26(2)	A yearly report before 1 st July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive mine closure plan for 2021-22 has not been submitted to this office.
34A(3)	Every lessee shall carry out a drone survey of his leased area and up to hundred metres outside the lease boundary within six months before submission of any mining plan document or modification thereto to the Indian Bureau of Mines for approval and shall submit processed output [digital elevation model (DEM) and Orthomosaic] images obtained from such survey or any other format as may be specified by the Indian Bureau of Mines in this regard to the concerned Regional Controller of Mines and the Controller General along with the application for approval or modification of mining plan.
45(5)(c)	The mining lease holder shall submit online Annual returns in respect of each mine to the Regional Controller and the authorized officer of the Indian Bureau of Mines, which shall be submitted before the 1st day of July each year for the preceding financial year in electronic form, along with a signed print copy of the same if it is not digitally signed, in the respective Form. In your case, you have not submitted the annual return for the year 2021-22 within the scheduled date, whereas the same has been submitted after the due date i.e. on 01/07/2022 which is delayed by 1 days.
45(7A) Read with Schedule II	Amount to be paid in case of violation under Rule 45, where the violation pertains to the delayed submission of return. In your case as you have violated the due date of submission of returns as mentioned above whereas you have not deposited such amount for such delay as per Schedule II.

- In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
- Mining operations can be suspended as per rule 11(2) in case of non-compliance of above relevant rules of MCDR 2017 as these above rules also affect the rule 11(1) i.e. Systematic scientific and responsible mining and/or state Government may be informed to take actions as per competent directives.
- As per provision of Rule 45(7), the Regional Controller of Mines may take appropriate action including order of suspension of **all mining operations and dispatches** on non-compliance of various provisions of Rule 45.
- You are also liable to pay an amount of Rs.10000/-per day for such days as per **Schedule-II**, read with Rule 45(7A) in case of non-compliance of various provisions of Rule 45.
- In context to the violations of Rule 45, you are advised to rectify above violation immediately. You are therefore directed to show cause within a period of 30 days from the date of issue of this letter as to why the action under Rule 45(7) and/or 45(7A) shall not be taken against you. No further notice will be given to you in this regard.
- You are advised to rectify the above violation immediately and intimate the compliance position to this office, within 45 days from date of issue of this letter.
- This letter has been issued with the approval of Regional Controller of Mines.
