विषय Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Rabarika Limestone, Sy
No. [338 P] Mine over an area of 4.0 ha located near Village- Rabarika, Tehsil-Jetpur, District-Rajkot in Gujarat.

महोदय Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 (MCDR, 2017) were found violated in your above mine during the MCDR inspection on 03.3.2023 FN in the presence of Sh. Deepak bhai bhannu bhai, Lessee rep.

RULE NO.	NATURE OF VIOLATION OBSERVED
11(1)	The mining operations were not being carried out as proposed in approved Review of Mining Plan vide 684(4) (1) MP-262/2019-20 खानिखस(उ)/GNR Dated 13.1.2020. Exploration -It was proposed to drill 04 No of 04 Core borehole, 25m each as earmarked in page-15 for 2020-21 and 2021-22 but no such exploration work done and reported till date. Exploitation -It was proposed to work & excavation of ROM production of 28409T for the year 2020-21 but you have done the ROM production of 31788.02T which is 3379.02T excess (11.89%) against proposed quantity and achieved 1310T for 2022-23 till date without approved RMP for the year.
11(4)	The holder of a mining lease shall submit the mining plan to the competent authority for review at least one hundred and eighty days before the expiry of five years period for which it was approved on the last occasion, for mining operations for a period of five subsequent years. In your case, last scheme of mining was approved dated 13/1/2020 for the year 2019-20 to 2021-22 & No Review of mining plan under provision of rule is submitted to this office till date.
28(1)	The holder of a mining lease shall send to the authorized officer, as the case may be, and the State Government a notice in Form-E, when the mining & mineral processing operation in the mine or part thereof are dis-continued for a period exceeding ninety days so as to reach them within one hundred and twenty days from the date of such temporary discontinuance. In your case, you have not submitted discontinuance notice wef 01.5.2022 to IBM Gandhinagar office so far.
26(2)	A yearly report before 1 st July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive mine closure plan for 2021-22 has not been submitted to this office.
34A(3)	Every lessee shall carry out a drone survey of his leased area and up to hundred metres outside the lease boundary within six months before submission of any mining plan document or modification thereto to the Indian Bureau of Mines for approval and shall submit processed output [digital elevation model (DEM) and Orthomosaic] images obtained from such survey or any other format as may be specified by the Indian Bureau of Mines in this regard to the concerned Regional Controller of Mines and the Controller General along with the application for approval or modification of mining plan.

- In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
- Mining operations can be suspended as per rule 11(2) in case of non-compliance of rule 11(1), and any other relevant rules of MCDR 2017 as these rules also affect/ ensures systematic scientific and responsible mining and/or state Government may be informed to take actions as per competent directives.
- You are advised to rectify the above violation immediately and intimate the compliance position to this office, within 45 days from date of issue of this letter.
- This letter has been issued with the approval of Regional Controller of Mines.
