02. Monthly income of the Family on property and monthly income of the earning member(s) of the Family other than Family Pension (including the means of living so far after the sad demise of the Government Servant).

(Note 1: The applicant is required to furnish a certificate from the Competent Authority. In case, the applicant claiming no means of income other than the final benefits granted by the Bureau of Mines, he has to furnish a certificate from the respective competent state authorities not below the rank of Tahsildar stating that "No one in the family of the deceased/ retired employee is employed and/or the dependent family members are having no means of livelihood"

02. The applicants may submit duly sworn affidavits declaring the Monthly income of the Family on property and monthly income of the earning member(s) of the Family other than Family Pension (including the means of living so far after the sad demise of the Government Servant).
