C I R C U L A R

21 posts of Deputy Controller of Mines in pay Level – 12 (Rs. 78800-209200) is vacant in Indian Bureau of Mines under the Ministry of Mines which is to be filled up by deputation (including short term contract).

02. Duties in brief of Deputy Controller of Mines in IBM are as under:

Inspection of Mines for systematic development, conservation of minerals and protection of mines environment under the Mines and Minerals (Development and Regulation) Act, 1957 and rules made there under. To prefer court complaints for violations of Mines and Minerals (Development & Regulation) Act and rules made there under. To inspect and to collect the samples under Environment (Protection) Act, 1986. To advise the mine owners on the adoption of appropriate technology for prospecting and mining; to advise on beneficiation and utilisation of submarginal grade ore and rejects; protection of environment in mining areas. To undertake site inspections in connection with processing of mining plan/scheme of mining. To approve the scheme of mining in respect of category 'B' mines as and when empowered. To monitor the mining activities in accordance with the approved mining plan/scheme of mining. To process stoping proposals for underground mines. Technical data processing and retrieval as and when required. To work as officer incharge and Head of Office as and when assigned. Any other duties that may be assigned by the superior officers

03. As per the Recruitment Rules to the post of Deputy Controller of Mines, the candidates to be considered for appointment by deputation (including short term contract) should be Officers of the Central Government or State Government or Union territories or autonomous or statutory organization or public sector undertakings or University or recognised research institution:

(A) (i) holding analogous post on regular basis in the parent cadre or department; or

(ii) with 5 years service in the grade rendered after appointment thereto on a regular basis in posts in level-11 in the pay matrix (Rs.67700-208700), and

(B) possessing the following educational qualifications and experience :-

(a) Bachelor of Engineering or Technology in Mining Engineering from a recognised University or institution ;

(b) Ten years experience in core Mining activity in:-

(i) Managerial position in Metalliferous (Non-coal) mines which includes the period as graduate or management or junior trainee engineer; or

(ii) Government Department dealing with mines and minerals, in level-10 in the pay matrix (Rs.56100-177500) or above in pay matrix or

- (C) (i) Master of Engineering or Technology in Mining Engineering from a recognised University or institution;
(ii) Eight years experience in core Mining activity in:-
(a) Managerial position in Metalliferous (Non-coal) mines which includes the period as graduate or management or junior trainee engineer; or
(b) Government Department dealing with mines and minerals, in level-10 in the pay matrix (Rs.56100-177500) or above.

Note 1. The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, the deputationists shall not be eligible for consideration for appointment by promotion.


Note 2. The period of deputation including the period of deputation in another Ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not exceed four years.

Note 3. The Maximum age limit for appointment by deputation shall be not exceeding fifty six years as on the closing date of receipt of applications.

04. The deputation period will be initially for 03 years and will be considered for further extension on the basis of requirement of this department and NOC from the parent department. However, the officer may also consider for pre-mature reversion to the parent cadre by serving 03 months advance notice to the parent department as well as to the officer in terms of provisions contained under DOPT OM No. 6/8/2009-Est.(Pay II) dated 17-06-2010.

05. Applications received after the closing date will not be entertained. Also, advance copies of application or not accompanied with all above certificates/enclosures are liable to be rejected.
