विषयSub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Babarzar Limestone Mine, [1-B/part] over an area of 76.89 ha. located near Village- Ranavav, Tehsil- Ranavav, District-Porbandar in Gujarat.

महोदय,

The following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection carried out by Sh. Snehalkumar Patel, AME on 02/05/2023 (AN) in the presence of your representative Shri Dhrumil Makhecha & Team.

RULE NO.	NATURE OF VIOLATION OBSERVED
11(1)	The Mining operation are being carried out in violation of the following provision of the approved mining plan, which was approved vide letter no. 684(4)(1)/MP-278/2020-21-GNR Dated-09-10-2020 for the period 2020-21 to 2024-25 (Up to 23.11.2025). In Part-A, 1.0 Geology and Exploration Para-(i) Future programme of exploration...given table, it was proposed that 5 (Five) Bore holes in the year 2021-22 & 5 (Five) Bore holes in the year 2022-23, which have not been done yet.
24(1)	The holder of a mining lease shall submit a Final Mine Closure Plan to the competent authority for approval two years prior to the proposed closure of the mine. As your mining lease as per our office recorded is going to expire in 23.11.2025.
34A	<b>Digital aerial images of mining lease area. — (1) Every lessee having—</b> (a) an annual excavation plan of one million ton or more in a particular year; or (b) leased area of fifty hectare or more, shall carry out a drone survey of the leased area and up to hundred meters outside the lease boundary in the month of April or May every year and submit the processed output [digital elevation model (DEM) and Orthomosaic ] images obtained from such survey or any other format as may be specified by the Indian Bureau of Mines in this regard to the Controller General on or before 1st day of July every year. As per Order No. 8/1/2021-Mines VI Dated 11/11/2022 issued from Ministry of Mines, the Compliance date of Rule 34(A) of MCDR 2017 has been extended from 01/07/2022 to 31/12/2022. <b>(2) Every lessee, other than those covered under sub-rule (1), shall submit soft copy of high resolution Geo referenced Ortho-rectified Multispectral satellite images of the leased area and up to hundred meters outside the lease boundary taken in the month of April to June of every year, to the Controller General on or before 1st day of July of the that year in the standards formats such as Geo TIFF along with metadata or any other format as may be specified by the Indian Bureau of Mines in this regard:</b> As per Order No. 8/1/2021-Mines VI Dated 11/11/2022 issued from Ministry of Mines, the Compliance date of Rule 34(A) of MCDR 2017 has been extended from 01/07/2022 to 31/12/2022. <b>In your case it is observed that you have failed to submit the Digital aerial Image as per rule till date.</b>

02. On examination of office record, it is found that you have not submitted any reply of violation pointed out on 04-10-2022 to this office till date and it is found that violation of provision of rule 34A is still persists.

03. इस संदर्भ में आपका ध्यान आकर्षित किया जाता है कि उपरोक्त नियमों का उल्लंघन खनिज संरक्षण एवं विकास नियमावली, 2017 के नियम 62 के अंतर्गत दंडनीय अपराध है।

04. खनिज संरक्षण एवं विकास नियमावली, 2017 के नियम संख्या 11(1) तथा अन्य नियमों की पालना नहीं होने से व्यवस्थित एवं वैज्ञानिक तरीके से खनन पर विपरीत प्रभाव पड़ता है। अतः उपरोक्त नियमों की पालना नहीं करने पर नियम 11(2) के अंतर्गत खनन क्रियाएं स्थगित (निलंबित) की जा सकती हैं अथवा राज्य सरकार को उचित कार्यवाही करने की अनुशंसा भी की जा सकती है।
05. अतः आपको निर्देशित किया जाता है कि आप उपरोक्त उल्लंघनों का अति शीघ्र सुधार कर इसके सुधार की स्थिति की सूचना इस पत्र के जारी होने की तिथि से 45 (पैंतालिस) दिनों के भीतर इस कार्यालय को प्रेषित करें।
06. यह उल्लंघन पत्र क्षेत्रीय खान नियंत्रक के अनुमोदन पश्चात जारी किया जा रहा है।
