महोदय / Sir,

As per the office record and based on the inspection done on 04/05/2023 the following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine.

<u>Rule No.</u>	<u>Nature of violation observed</u>
34A(3) read with Rule 34A(5)	The submitted output/details of the drone survey were not found as per the SOP issued by IBM under rule 34A(5).
Rule 46	The appointment / termination Notice of Geologist has not been received.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservation and Development Rules, 2017.

03. Mining operations can be suspended as per Rule 11(2) in case of Non-Compliance of Rule 11(1), and any other relevant Rules of MCDR 2017 as these above Rules also affect the Rule 11(1) i.e., systematic and scientific development of mineral resources and protection of environment in mines and /or State Govt. may be informed to take action as per competent directives.

04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
