Sub: Violation of provisions of MCDR, 2017 in respect of your Bainibasa Graphite Mine over an area of 58.704 ha in Rayagada district of Odisha State.

Sir,

The following provisions of Mineral Conservation and Development Rule, 2017 (MCDR, 2017) were found violated in respect of the above said mine during inspection on 27.10.2023 by Shri Ashok Kumar Pany, Assistant Mining Engineer of this office, in presence of mines manager.

Rule No.	Proposed as per Mining Plan/ Rule Position	Violation
11(1)	(i) As per the Review of Mining Plan approved vide letter No. RMP/A/38-ORI/BHU/2020-21 dated 12.01.2021 it was proposed to drill 39 nos. of exploratory bore holes in the year 2021-22.	(i) During inspection it was observed that 21 nos. of bore holes drilled during the year 2021-22 and the balance bore holes has not been drilled till date.
45(7)	Holder of mining lease shall not submit incomplete or wrong or false information in annual return.	On scrutiny of annual return submitted for the year 2022-23 the following deficiencies observed:- (i) In Part-V, exploration at the beginning of year and cumulative is not correctly furnished. In Sl No.6, the machinery details is furnished as nil. The same cannot be nil as production carried out during the year. (ii) In Part-VI, SL No. 5, sale and dispatch, it is furnished as domestic transfer to M/s Pradhan Industries. As the same is lessee of mine, it should be captive consumption and in case of

		captive consumption sale value should be zero.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.

Besides, inability to comply with the provisions of Rule 11(1) is liable for suspension of mining operations according to the provisions of Rule 11(2) of MCDR, 2017. Also non-compliance of Rule 45 leads any action as per Rule 45(7) of MCDR, 2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty five) days from issue of this letter.
