महोदय/ Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection made by the undersigned on 21.09.2023 in the presence of Shri G.N Choduhary , Mining Geologist .

<u>RULE NO.</u>	<u>NATURE OF VIOLATION OBSERVED</u>
11(1)	Mining Operation has not been carried out in accordance with the approved Review and Updation of Mining Plan of vide letter no. 614(2)/MS-A-175/08-DDN dated 08-03-2021 to the following extent: i. Benches formation shall be done from 2094 mRL to 2082 mRL with 2 benches having 6 meter of respective bench height in mine bur during the inspection benches height more than 6 meter. Also Benches height of existing benches found more than proposals.

- In this connection, it is brought to your notice that the violation of rule 11(1) an offence punishable under Rule 62(1) of MCDR Amendment Rules 2021.
- You are advised to rectify the above violations immediately and intimate the compliance position to this office within 45 days from date of issue of this letter.
