विषय/Sub: Violation of provisions of Mineral Conservation & Development (Amendment) Rules, 2021, in respect of your Manakudayan Limestone Mine over an area of 44.805 Ha in Manakudayan Village, Sendurai Taluk, Ariyalur District, Tamil Nadu.

महोदय/Sir,

The following provisions of the MCD(A)R, 2021 were found violated in your above mine during the inspection on 23/09/2023 by the undersigned in the presence of Mr. S. Duraimurugan, DGM, Mr. K. Elansurian, AGM & Mr. J. Ravi, AGM:

Rule No.	Nature of Violation
11(1)	<p>Mining operations have not been carried out in accordance with the Review of Mining Plan approved vide Letter No. TN/TKD/LST/MMP-2070.MDS dated 11.01.2021 to the extent indicated below:</p> <p>(i) There was a proposal to excavate 9,77,00 tonnes of ROM during the year 2022-23 against which only 7,27,438.42 tonnes of ROM was excavated during the year.</p> <p>(ii) There was a proposal to remove 7,24,164 m<sup>3</sup> of Overburden &amp; Interburden during the year 2022-23 against which only 5,95,456.11 m<sup>3</sup> was removed during the year.</p> <p>(iii) There was a proposal to remove 34,300 m<sup>3</sup> of Top Soil during the year 2022-23 against which only 26,985 m<sup>3</sup> was removed during the year.</p> <p>(iv) There was a proposal to maintain the stripping ratio at 1:1.39 during the year 2022-23 which was maintained at 1:1.63 during the year.</p> <p>(v) There was a proposal to afforest 0.8 Ha with 2,000 nos. of saplings during the year 2022-23 against which only 0.08 Ha was afforested with only 200 nos saplings during the year.</p>

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62(1) of Mineral Conservation and Development (Amendment) Rules, 2021, with imprisonment for a term which may extend to two years or with fine which may extend to rupees five lakhs, or with both, and in the case of a continuing contravention, with additional fine which may extend to rupees fifty thousand for every day during which such contravention continues after conviction for the first such contravention.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
