The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above said mine during inspection carried out on 30/12/2023 by undersigned along with Dr. Sudhakar T.L., SMG in presence of Shri Ekambrappa, Mines Manager, Shri M. Peddanna, Geologist and Shri Imthiyaz V., Mining Engineer

Rules	Nature of Violations observed
45(7)	In the Annual Return submitted for the year 2022-23, following discrepancies were observed i. <b>In PART-V (General Geology &amp; Mining) (2) Reserve and Resources estimated</b> : Modified to the approved Mining Plan document was approved on 29/11/2022, however, updated Reserve & Resources figures are not furnished in the “Assessed during the year” column in the Annual Return submitted.

02. The mining operations and dispatches may be suspended and any action under sub-rule (7) of Rule 45 of MCDR 2017 read with MCDR (Amendment), 2021 may be initiated.

03. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR (Amendment), 2021.

04. You are therefore directed to show cause within a period of **thirty (30) days** from the date of issue of this notice, as to why action under sub-rule (7) of Rule 45 of and Rule 62 of MCDR (Amendment), 2021 shall not be taken against you.
