The following provisions of Mineral Conservation and Development Rules 2017 (MCDR, 2017), were found violated in your above mine during mine inspection by the undersigned on 14.12.2023 in the presence of Sri K.C. Sahu, DGM (Mines) and Sri A.M. Barbhuiya, Geologist.

- 02. In this connection, it is brought to your notice that the above violations constitute an Offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.
