11 (1)	The Review and updation of Mining plan was approved by IBM vide letter no. 279/869/2005/BNG dated 14/12/2021 for the period 2022-23 to 2026-27 & Modifications to the approved Mining plan was approved vide letter no 279/869/2005/BNG dated 06/06/2023, for the period 2023-24 to 2026-27. The deviations observed in mining operation vis-à-vis approved document are given below.
	 i. The systematic stage wise waste dumping at temporary waste dump (ID-3) proposed for the year 2023-24 between Section D-D' to E-E' is not carried out as the existing weighbridge located near to Section E-E' has not been dismantled and is restricting the waste dumping area. ii. 206 m Retaining wall & 216-meter garland drain construction proposed for the year 2022-23 is not carried out as per proposal.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR (Amendment), 2021.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
