Sub: - Violation of the provisions of MCDR, 2017 in respect of your Moiong Block-I Limestone Mine (38MEG03008) over an area of 4.80 Ha. in East Jaintia Hills Dist. of Meghalaya state.

Sir,

On field inspection by the undersigned, following provisions of MCDR 2017 have been found violated in your above mine –

Rule No.	Nature of violation observed
34A(2): (2) Every lessee, other than those covered under sub-rule (1), shall submit soft copy of high resolution geo-referenced ortho-rectified multispectral satellite images of the leased area and upto hundred metres outside the lease boundary taken in the month of April to June of every year, to the Controller General on or before day of July of the that year in the standards formats such as GeoTIFF along with metadata or any other format as may be specified by the Indian Bureau of Mines in this regard:	No any copy of high resolution geo-referenced ortho-rectified multispectral satellite images of the leased area and upto hundred metres outside the lease boundary has been submitted by you.

2. In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 62 of MCDR 2017.
3. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
4. You are therefore advised to rectify the above violation immediately and intimate the position to this office within a period of 45 (Forty Five) days from the date of issue of this letter.
