The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 24.06.2023 by the undersigned in the presence of Shri Lakshminarayana, Senior General Manager, Shri Gopal Joshi, DGM and others.

Nature of Violations observed
Modification to the approved Review and Updation of Mining plan was approved
by IBM vide letter no. 279/377/93/BNG dated11/12/2020 for the period 2020-21 to
2024-25 The deviations observed in mining operation vis-à-vis approved document
are given below:
<ul> <li>i) It was observed during the inspection that the development of 46,455tonnes have been proposedduring the year 2022-23, against which only 18,400tonnes of waste has been generated. There is a deviation of more than 60% less in development.</li> <li>ii) Plantation of 2175 saplings has been proposed on the backfilled area during the year 2022-23, against which no plantation has been carried out.</li> </ul>
The holder of mining lease shall submit a yearly report for the year 2022-23 on protective measures including reclamation and rehabilitation before 1 <sup>st</sup> July of every year. The same has not been submitted.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office **within 45 (Forty-Five) days** from the date of issue of this letter.
