Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 30.11.2023 by the undersigned in the presence of Sri Shiojee Roy, DGM(Mines), Sri Nagur Meera Saheb Sheik, Geologist and Shri Tejnath, Mining Engineer.

. ,	utilization as at the end of the year in hectares has not been furnished
	correctly.
	b) The ex-mine price of mineral shall be the per unit cost of production in case
	of captive mines.

- 02. With reference to this office letter of even number dated 15.11.23 regarding scrutiny of Annual Return, no reply has been received in this office.
- 03. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.
- 04. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 05. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
