Subject:- Violation of provisions of Mineral Conservation and Development Rules, 2017, in respect of your **Bharweli Manganese Mine** over an area **182.3004 Ha** in Balaghat district of M.P. State.

Sir,

Undersigned has inspected your mine in the presence of your representative Shri R.U Singh, Jt.G.M – Mines & Agent, Shri Mayank Jain (Mine Manager) and Shri Vinay Rahangdale (Geologist) on 10/10/2023. The document of above mentioned mine was approved vide letter No.-MP/Balaghat/Manganese/MPLN/G-06 /2021-22 dated 29/04/2022 incorporating proposal of working from 2022-23 to 2026-27. Following provisions of MCDR 2017 were found violated in your mines at the time of inspection.

<p>11(1)of MCDR 2017</p>	<p>1. Mining operations under mining lease.–(1) No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section (2) of section 5</p> <p>During inspection it has been observed that the following provisions of the rule have been violated: -</p> <ol style="list-style-type: none"> 1. Mineral Stacks and Rejects were stacked in 7.5 m barrier and also outside the lease. 2. It was proposed to produce 44494 m3 of OB but only 8810 m3 of OB was produced. 3. Horizontal development in rock i.e Haulage and cross cut was proposed 1395 m but only 432.50 m was achieved. 4. Development proposed for Ore drive was 780 m but only 293 m was achieved. 5. Vertical Development (Winze/raise) proposed was 910 m but only 370.80 m was achieved. 6. PMCP measures as proposed for retaining wall and garland drains (140 m each) were not taken up.
<p>45(7)</p>	<p>If it is found that the holder of a mining lease or the person or company engaged in trading or storage or end-use or export of minerals, as the case may be, has submitted incomplete or wrong or false information in daily or monthly or annual returns or fails to submit a return within the date specified:</p> <p>In Annual Return for the year 2022-23 in form G1 submitted to the Regional Controller of Mines has found following discrepancy –</p> <p>12. Lease area (surface area) utilisation as at the end of year (hectares): Incomplete information is furnished.</p> <p>Further, as per the provisions of Rule 62(2) Mineral Conservation and Development (Amendment) Rules, 2021, contravention of this rule shall be liable with fine for an amount as specified in Schedule II if the necessary corrections not incorporated in referred back return as per the provisions of this rule within stipulated time.</p>

1. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.
2. The mining operations can be suspended under the rule 11(2) of MCDR-2017, if compliance of rule 11(1) of MCDR-2017 is not found satisfactory.
3. You are advised to rectify the violations of above mentioned rules immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
