Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017, in respect of your Palaspani Manganese Mine, over an area of 54.129 hectare, situated in village-Palaspani and others, Tehsil- Sauser, District-Chhindwara of Madhya Pradesh State.

Undersigned has inspected your mine in the presence of Shri D.R Dekate, Mine Manger and QP, Shri Nikhil Kale (Geologist), Shri N Ramesh Babu (Project In charge) and other mines officials on 07/12/2023. Following provisions of MCDR 2017 were found violated in your mines at the time of inspection

1. Mining operations under mining lease.–(1) No holder of a mining lease shall commence or
carry out mining operations in any area except in accordance with the mining plan approved,
modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance
with the system established by the State Government pursuant to the proviso to clause (b) of
sub-section (2) of section 5
The document of above mentioned mine was approved vide letter No
MP/Chhindwara/Manganese/MPLN/MOD-15/21-22 dated 22/10/2021 incorporating proposal of
working from 2021-22 to 2025-26.
During inspection it has been observed that the following provisions of the rule have been
violated: -
Violated
1. It was proposed to produce 39960 T of Mn ore from dump working but only
19022.265 T of Mn ore was produced.
2. Pit was developed outside the lease boundary.
3. At many places stacking is done outside the lease boundary.
4. At many places Dumping is done outside the lease boundary.
5. Dump working is done outside the lease boundary also.

**1.** In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.

**2.** The mining operations can be suspended under the rule 11(2) of MCDR-2017, if compliance of rule 11(1) of MCDR-2017 is not found satisfactory.

**3.** You are advised to rectify the violations of above mentioned rules immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
