	During the inspection it was observed that the height of the benches are 7-8 m .
33	The holder of a mining lease shall, on or before the 30 <sup>th</sup> day of June every year submit to the
	authorized officer a digital copy along with a print copy of the surface geological plans and sections
	maintained under rule 32.
	However, the lessee has not submitted the copies of the plans and sections as per rule for the
	year 2022-23.
34A	The Digital aerial images of the mining lease area has not been submitted as per standard operating
	procedure

- 1) In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.
- 2) The mining operations can be suspended under rule 11(2) of MCDR-2017 if compliance of rule 11(1) of MCDR-2017 is not found satisfactory.
- 3) You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
