**Subject:** Violation of provisions of MCDR 2017 in respect of **Ittigehalli Limestone Mine (ML No.2472)** over an extent of 20.23 Ha having Mine code 38KAR07009, in Ittigehalli Village, Hosdurga Taluk, Chitradurga District of Karnataka State.

Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 21.12.2023 by the undersigned along with Shri. Gangadhar Bhakat, AME in the presence of Sri Muralibabu B. K, Mines Manager and other Mine officials

Rules	Nature of Violations observed
11 (1)	The Modifications to approved Review and updation of Mining plan was approved by IBM vide letter no. 279/616/98/BNG dated 12/04/2018, for the period 2018-19 to 2022-23. The deviations observed in mining operation vis-à-vis approved document are given below: i. Exploratory drilling has not been carried out against the back log of proposed 15 Core Borehole with a total meterage of 750m for the year 2018-19 & 2019-20. ii. During the year 2022-23, it was proposed to produce Limestone (ROM) of 6,00,000 tonnes by handling 1,60,000 tonnes of waste. However, only 49495 tonnes of Limestone produced by handling 13,800 tonnes (6900 m <sup>3</sup> ) of waste/OB. Only 9% of proposed production and development is achieved during the year.
26(2)	The holder of mining lease shall submit a yearly report on protective measures including reclamation and rehabilitation before 1 <sup>st</sup> July of every year. The same has not been submitted.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.

03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violations immediately and intimate the position to this office **within 45 (Forty-Five) days** from the date of issue of this letter.
