The following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection carried out by the undersigned in presence of Shri L. Ravi Ramu Naidu, Mines Manager & Mining Engineer, Sri. Nagarjuna, Geologist on 28/12/2023.

Rule 45(7)	 (i) As PART-V (General Geology & Mining) 4. Overburden and Waste (in m3) of the Annual returns for the year 2022-2023: The waste generation quantity is wrongly reported in tonnes instead of reporting in m3. (ii) As PART-VI (PRODUCTION, DESPATCHES AND STOCKS) (IRON ORE (MAGNETITE)) 3(ii) Grade-wise Production, Dispatches, Stocks and Ex-mine prices: The Ex-Mine price per tonne of Iron Ore lumps (Magnetite) below 45% Fe is not tallying with the sale value reflected under item 5. Sales-Dispatches effected for Domestic Purposes. Also, Ex-Mine price per tonne of Iron Ore fines (Magnetite) below 45% Fe observed to be much below the Average Sale price declared during the period 2022-2023.

- 02. The Mining operations and dispatches may be suspended and any action under sub rule (7) of Rule 45 of MCDR, 2017 read with MCDR (Amendment) Rules, 2021.
- 03. The fine may be imposed for submitting incomplete/ wrong/ false information in Annual Return as per Schedule-II of MCDR (Amendment) Rules, 2021.
