The following provision of the Mineral Conservation and Development Rules, 2017 was found violated in your above said mine during the inspection on 28.11.2023 by Sri D. Chandrasekhar Reddy, Asst. Mining Engineer accompanied by Sri K.Baskar , Chief Geologist and Sri R.Balamurugan Manager & Mining Engineer.

11(1)	Mining operations have not been carried in accordance with the modification to the Approved Mining Plan, approved vide letter no. TN/ALR/LST/ROMP/1573-MDS dated 11.11.2019.  (ii) There was a proposal to produce 225579 tonnes of Limestone and 11872 tonnes of waste during the year 2022-23, whereas, against the approved proposals only 107049 tonnes of Limestone and 978.26 tonnes of waste has been generated during the year 2022-23.
33	Print Copies of the Surface Geological Plan and Sections as required under rules 32 have not been submitted to Regional Controller of Mines, Indian Bureau of Mines, Chennai along with Annual Return for the year 2022-23.

- 02. In this connection, it is brought to your notice that the above violation constitute an offence punishable under Rule 62 of Mineral Conservation and Development Rules, 2017.
- 03. The mining operations can be suspended under Rule 11(1), if compliance is not found satisfactory.
- 03. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
