Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017(amended), in respect of your Vayalapadi Limestone mine over an extent of 3.57 ha in Vayalapadi Village, Kunnam Taluk, Perambalur District, Tamilnadu State.

Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection on 25.12.2023 by Sri D. Chandrasekhar Reddy, Assistant Mining Engineer in the presence of Shri Mathukaruppan, Owners representative.

Rule No	Nature of Violation
11(1)	The mining operations in the lease area are not carried out as per the approved Review of Mining Plan letter no. TN/PBR/LST/ROMP-1481-MDS dated 13.04.2018 for the period from 2018-19 to 2022-23. a) There is a proposal in the approved Review of Mining Plan document to produce 45,250 tonnes of ROM production during the year 2022-23, against the proposal only 31,370 tonnes of production achieved.

- In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development (Amended) Rules 2021, with imprisonment for a term which may extend to two years or with fine which may extend to rupees five lakhs, or with both, and in the case of a continuing contravention, with additional fine which may extend to rupees fifty thousand for every day during which such contravention continues after conviction for the first such contravention.
- 03. The mining operation can be suspended under Rule 11(2) if the compliance of Rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
