महोदय/Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection carried out by the undersigned along with Sri. H.M.Shivakumar, Asst. Controller of Mines in presence of Shri Dharm Tejaswi, Agent & Nominated Owner, Shri Rudraiah A M, Mines Manager & Mining Engineer, on 19/01/2024.

Rule	Nature of violations observed
11 (1)	The Mining operations are required to be carried out in accordance with the Review and Updation of Mining Plan document approved vide letter no. 279/780/2003/BNG dated 21/01/2022. However, during the inspection deviations were observed in mining operation vis-à-vis approved document and are as follows:
	In the Iron ore reef pit (1) it is proposed to maintain the maximum height of the benches at 6m and minimum width of the benches at 6m. However, it is observed that between sections A-A' to B-B' the width of the benches are not maintained as per the approved proposals.

02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
