The following provisions of the Mineral Conservation and Development Rules, 2017 read with Mineral Conservation and Development (Amendment) Rules, 2021 were found violated during the mining operation for the year 2022-23 in your above said mine during inspection on 24.11.2023 for MCDR and SDF validation by the undersigned along with Dr. Omkesha Murthy, Regional Mining Geologist.

	The Mining operations are required to be carried out in accordance with the approved

	dated 31/12/2020. However, during the inspection deviations were observed in mining

	-Ore production proposed for the year 2022-23 is 70,000 MT ore which includes 17218
	MT ore from primary development and 52,782 MT from stope production (from the stopes between 3 rd sub level to 1 st level 11250 MT and 8L to 6 th level 41782 MT) against which it is reported that 31295 MT Ore and 0 MT production from 8L to 6th
	level stope is achieved, it is observed that the total production was proposed from the stope between 3 rd sub level to level 1, but no stope development from 8L to 6th level is
	carried out during the year 2022-23. Also, there is no development of ore drive proposed for the year 2022-23 at Level 3, 6 and 8 respectively.
