**विषय/Subject:** Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your Shivasandra Manganese Ore Mine (ML No.2636) over an area of 21.38 Ha. in Shivasandra Village, Gubbi Taluk, Tumukuru District, Karnataka state. (Mine Code 40KAR19029).

महोदय/Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection carried out by the undersigned along with Sri. H.M.Shivakumar, Assistant. Controller of Mines in presence of Sri. R. Kenchappa, Mines Manager on 15/03/2024.

Rule	Nature of violations observed
Rule 45(7)	<b>As part PART-VI (PRODUCTION, DESPATCHES AND STOCKS) (MANGANESE ORE) of the Annual Returns submitted for FY 2022-2023:</b> As per the Review and Updation of Mining Plan document approved vide letter no. 279/954/2007/BNG dated 06/05/2020, It was proposed to produce 9000 Metric Tonnes of Mn Ore and 1000 Metric Tonnes of Mn Ore Rejects and approved in line with the Maximum EC quantity of 10000 Metric Tonnes of Manganese Ore. However, Production of 9900 Metric Tonnes of Manganese Ore and 9900 Metric Tonnes of Manganese Ore rejects under <b>PART-V (General Geology &amp; Mining) 3. Subgrade-Mineral Reject (in tonnes) (MANGANESE ORE)</b> totaling to 19800 Metric tonnes are reported which is a deviation from the Maximum approved quantity in the Mining Plan and Environmental Clearance dated 20/09/2008.

- The Mining operations and dispatches may be suspended and any action under sub rule (7) of Rule 45 of MCDR, 2017 read with MCDR (Amendment) Rules, 2021.
- The fine may be imposed for submitting incomplete/ wrong/ false information in Annual Return as per Schedule-II of MCDR (Amendment) Rules, 2021.

1/30049/2024 In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017 read with MCDR (Amendment) Rule, 2021.

05. You are therefore, directed to show cause within a period of thirty **(30) days** from the date of issue of this notice, as to why action under sub rule (7) of Rule 45 and Rule 62 of MCDR 2017 read with MCDR (Amendment), 2021 shall not be taken against you.

06. You are herewith given **30 days-time** for reply and rectification of the violation from the date of issue of this notice. Please note that no further notice will be given to you in this regard.
