विषय: Violation of provisions of Mineral Conservation and Development Rules, 2017, in respect of your Baharregaon Moulding sand Mine over an area of 2.83 hectare (Mine Code **42CHG15001**) located in District Rajnandangaon of Chhattisgarh State

महोदय,

आपकी उपरोक्त खान का निरीक्षण दिनांक 26.12.2023 को श्री देबदुर्लभ दाश, क्षेत्रीय खनन भूविज्ञानी द्वारा श्री रमेश दकालिया की उपस्थिति में किया गया तथा खान के निरीक्षण में पाया गया कि आपने खनिज संरक्षण एवं विकास नियमावली 2017 के निम्नलिखित उपबंधों का उल्लंघन किया है।

Rule No.	Nature of violation observed in detail
Rule 35 (4)	Every holder of a mining lease shall achieve at least three-star rating within a period of four years with effect from the 27th February, 2017 or four years from the date of commencement of mining operations, as the case may be, and thereafter maintain the same on year- on- year basis” However as per self-assessment report (star rating template) submitted by you online, it is observed that you have not achieved 3 Star Rating as required; because you achieved only 02 star rating for the year 2022-23.

02. The provision of rule 35 of MCDR 2017 states that;

- (4A) *The Regional Controller or the authorised officer of the Indian Bureau of Mines may suspend the mining operations in those mines where,—*
- (a) *at least three-star rating has not been achieved within a period of four years with effect from the 27<sup>th</sup> February, 2017 or four years from the date of commencement of mining operations, as the case may be, or at least three-star rating has not been maintained on year-on-year basis,*

03. In this connection it is brought to your notice that the above violation constitutes an offence punishable under Rule 62 of MCD (Amendment) Rules, 2021 and mines may be suspended in case of non-compliance of Rule 35 (4) of MCDR 2017.

04. You are furthermore directed to show cause within a period of Fourty Five (45) days from the date of issue of this letter as to why action under Rule 35(4A) shall not be taken against you.

05. Please note that no further notice will be given in this regard.
