

Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Dhanora Limestone Mine (38.024 Hectares, Mine Code: 38MPR12082) in Dhanora Village, Gandhwani Tehsil, in Dhar District of Madhya Pradesh State.

Sir,

The undersigned inspected your mine on 10/10/2023 in the presence of your representative Shri Vijay Keshav Chakunde (Sr. GM mines), Shri Siyaram Mishra (Dy. Manager Geology), Shri Shailendra Kumar Patel (Geologist) and other mines officials. The latest Mining Plan of above mentioned mine was approved vide letter No. DHR/LST/MPLN-1161/NGP/2015 dated 30.07.2016 incorporating proposal of working for first five years. Following provisions of MCDR 2017 (as amended up to 3rd November, 2021) were found violated in your mines at the time of inspection.

- 02. Non-compliance of the rule 11(1) of MCDR, 2017 may lead to the suspension of mining operations under the provisions of rules 11(2) of Mineral Conservation and Development Rules, 2017.
- 03. Further, it is brought to your notice that the above violations constitute an offense punishable under rule 62 of Mineral Conservation and Development Rules, 2017.
- 04. You are therefore advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
