Sir,

The undersigned inspected your mine on 26/03/2024 in the presence of Shri Shashi Shekhar Ray, (Mines Manager), Shri Amit Biswas, (Geologist) and other mines officials. The latest Review of Mining Plan of above mentioned mine was approved vide letter No. MP/Satna/Lst./RMP-39/2019-20 dated 31.03.2020 incorporating proposal of working from 2020-21 to 2024-25. Following provisions of MCDR 2017 (as amended up to 3rd November, 2021) were found violated in your mines at the time of inspection.

- 03. Further, it is brought to your notice that the above violations constitute an offense punishable under rule 62 of Mineral Conservation and Development Rules, 2017.
- 04. You are therefore advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
