Sub.: Violation of provisions of Mineral Conservation and Development Rules, 2017, in respect to your **Tilaura Limestone Mine (3.774ha), Mine Code 38MPR35230** in Tilaura Village of Satna Dist M.P.

Sir,

The following provision of Mineral Conservation and Development Rules 2017 were found violated in your above mentioned mine during the inspection by the undersigned on **28.02.2024** in presence of Shri. Shyamal Kishore Kumar GM (Mines) and Shri Vineet Singh (Mining Engineer).

<b>Rule 11(1)</b>	<p><i>No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section (2) of section 5.</i></p> <p>i. Only 5000 T were produced against the proposed 15,187 T and against the proposed 37,378 Cu.m waste generation only 2900 Cu.m reported which distorting the proposal by 67%.</p>

*maintained up to date within three months in case of category 'A' mines as referred to in clause (a) of sub-rule (2) of rule 55, and within twelve months in the case of any other mine.*

The plans and sections have not been updated as required.

2. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.

3. You are advised to rectify the above violations immediately and intimate the position to this office within a period of 45 days from the date of issue of this letter.
