The following provisions of the Mining Conservation and Development Rules, 2017 were found violated in your mine during the inspection carried out on 06/06/2024 by undersigned in presence of Sri. Prakash Y, Mines Manger, Shri Abhay S, Geologist and other mine officials.

Rules	Nature of Violations observed
45(7)	As per provision of Rule 45(5)(b) "monthly return which shall be submitted before the tenth day of every month in respect of the preceding month in electronic form". The monthly return of the said mine for the month of December 2023 has been submitted on 11 th January 2024 which is after the due date. In the instant case the monthly return is submitted 02 day late from the due date of submission.
	The late fine to be paid @ Rs. 10,000/- per day i.e. 10,000 x 2 days = Rs, 20,000 (Rupees Twenty Thousand only).

- 02. The mining operations and dispatches may be suspended and any action under sub-rule (7) of Rule 45 of MCDR, 2017 may be initiated.
- 03. The said penalty is to be paid through **"https:/bharathkosh.gov.in"** web portal under the purpose head "Non submission/faulty Monthly Returns" in favour of **"137321-Regional Controller of Mines, IBM Bangalore"**.

- 04. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.
- 05. You are therefore directed to show cause within a period of **thirty (30) days** from the date of issue of this notice, as to why action under sub-rule (7) of Rule 45 of and Rule 62 of MCDR (Amendment), 2021 shall not be taken against you.
- 06. You are advised to rectify the above violations immediately and intimate the position to this office **within 30 (thirty) days** from the date of issue of this notice.
