Sub : Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Jaribahal Iron Ore Mine (Mine Code: 30ORI08120) over an area of 107.44 Ha area situated in Keonjhar Dist of Odisha State--reg

Sir,

The following provisions of Mineral Conservation & Development Rules, 2017 were found violated during inspection your above mine on **14-03-2024** by Shri Prashant S. Hegde, Regional Mining Geologist of this office in presence of S/Shri D.N Parida, Mines Agent, Prafulla Kumar Parida, DGM(Geology), S.K. Panda, Mines Manager, S.K. Prusty, Mining Engineer, Pritam Keshari Patra, Geologist and other mine officials.

Rule No.	Nature of violation observed
37(2)	Management of western part of Overburden Wastes Dump No.2 has not been proper due to non-development of terraces to reduce the dump height and not suitable protective measures to prevent the escape of material therefrom & dump stabilization.
45(5)(b)	Monthly return of April-2023 in form F-1 has been submitted on 10/05/2023 thereby made one day delay in submission. It may attract the delay amount of Rs 10,000/-- as per Schedule-II under Rule 45(7A).
45(7)	On examination of submitted Annual Return of FY 2022-23, it is found to be incomplete /wrong as furnished below. (i) <u>Item No. 3 of Part-V</u> : The information furnished related to subgrade-mineral reject has not been matching with actual. (ii) <u>Item No. 3(ii) of Part-VI</u> : The ex-mine price calculations were not matching as per rule 45(8)(b)(V) considering captive mine/consumption and/or as per rule 45(8)(b)(II) where domestic sales occurred under section 8A(7A) of amended Act. (iii) Part-VII : Cost of production calculation i.r.o. Exploration cost, over-head cost and depreciation cost and payment made towards bid premium (under other) have not been matching.

02. In this connection, it is brought to your notice that the above violations constitute an offence, punishable under Rule 62 of MCDR, 2017. Further, the amount/fine related to delay in submission of Monthly return of April-2023 may be deposited through Bharat Kosh Portal to PAO IBM Nagpur, DDO IBM Bhubaneswar, under item Non-submission /faulty Monthly Returns.
