विषय/**Subject** : Violation of provisions of MCDR 2017 in respect of your Bheemasamudra Mn ore mine (ML No. 1931/1997), overran extent of 6.88Ha having minecode of 12KAR07001 situated in Bheemasamudra illage, Chitradurga Taluk & District of Karnataka State.

महोदय/Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 07/06/2024 undersigned in the presence of yourself, Mine manager and Dr. C.P. Prasanna Kumar, Qualified Persons and others.

Rule	Nature of Violations Observed
45(7)	<p>On examination of the Monthly and Annual Returns of the said mine, it is observed that till date there are no records of receipt of Monthly/Annual returns submitted by the lessee under Rule 45 of MCDR ,1988/2017 to Indian Bureau of Mines.</p> <p>As per provision of Rule 45(5)(b) of MCDR, 2017 (amended on 03/11/2021), Monthly return shall be submitted before the tenth day of every month in respect of the preceding month in electronic form and Annual Return and Annual return shall be submitted before 30<sup>th</sup> June of every year in respect of the preceding year in electronic form. Non-submission of Monthly/Annual Returns in the stipulated time-line will attract penalty @₹10,000/- per day. Further, as per Rule 45 of MCDR, 2017 (amended on 21/01/2024), non-submission of Monthly/Annual Returns in the stipulated time-line will attract penalty @₹5000/- per day. In the instant case, Monthly/Annual Returns not submitted till date.</p> <p>In the instant case, total penalty under Rule 45(7) of MCDR, 2017 exceeds the maximum limit of Rs. 5,00,000/-, however, by considering the provision of sub-section (2) of Section 21 of MM(DR) Act, 1957, you are hereby advised to pay the penalty of Rs. 5,00,000/- (Rupees five lakh only).</p>

2. The Mining operations and dispatches may be suspended and any action under subrule (7) of Rule 45 of MCDR ,2017 may be initiated.
3. In this connection, it is again brought to your notice that this violation also constitutes an offence punishable under Rule 62 of MCDR, 2017.
4. **The said penalty may be paid through <https://bharatkosh.gov.in> web portal under the purpose head “Non submission/faulty Monthly Returns, & Annual Returns in favour of “137321-Regional Controller of Mines, IBM, Bangalore” and the status of compliance to be communicated to this office immediately.**
5. You are therefore, directed to show cause within a period of thirty (30) days from the date of issue of this notice, as to why action under subrule (7) of Rule 45 and Rule 62 of MCDR, 2017 shall not be taken against you.
6. You are herewith given **30 days time** for reply and rectification of the violation from the date of issue of this notice. The fine for the late submission of Returns is to be made immediately as per Schedule-II of MCDR (Amendment) Rules, 2024 dated 21.01.2024. Please note that no further notice will be given to you in this regard.
