Sub : Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Siljora Kalimati Iron and Manganese Ore mine /block (Mine Code: 40ORI08061) over an area of 713.51 Ha area situated in Keonjhar Dist of Odisha State--reg

Sir,

The following provisions of Mineral Conservation & Development Rules, 2017 were found violated during inspection your above mine on **25-04-2024** by Shri Prashant S. Hegde, Regional Mining Geologist of this office in presence of S/Shri D.N Parida, Mines Agent, Prafulla Kumar Parida, QP & DGM(Geology), Janmejy Mohanta, Mines Manager, Mohammad Shahrukh, Mining Engineer and other mine officials.

Rule No.	Nature of violation observed
11(1)	The mining operations are not being carried out as per Approved modified Mining Plan No. BBS/KJR/IRON-MN/2170/MPM/2022-23 dated 30/06/2022, to the extent as mentioned below. (i) Exploration: 76 nos of DTH boreholes with 1874 total meterage were drilled so far against the proposals of 157 nos of boreholes for FY-2022-23 and 82 nos boreholes for FY-2023-24. (ii) During FY-2023-24, the stripping ratio / ore to OB ratio of 1:8.55 (in tonnes/m ³) achieved against the proposals of 1:12, due to significantly less OB wastes generation as compare to production achieved.
45(7)	On examination of submitted Annual Return of FY 2022-23, it is found to be in-complete /wrong as furnished below. (i) Part-VII: Payment made towards bid premium (under other) has not been considered for calculation of cost of production.

02. In this connection, it is brought to your notice that the above violations constitute an offence, punishable under Rule 62 of MCDR, 2017. Further, the mining operations can be suspended under rule 11(2) of MCDR 2017, if compliance of rule 11(1) is not found satisfactory.

03. You are advised to **rectify the above violations immediately** and **intimate the position to this office within 45 (forty five) days** from the date of issue of this letter.
