| Rule 31(4) | It is observed during inspection from the submitted drone data for the year 2023-24 and surface plan updated as on 31.03.2024 that there are difference/error in elevation(mRL) in the maintained surface plan. The drone data indicates bottom mRL of Southern portion Pit-1 as 414 mRL (N-1889177, E-715099 to N-1889175, E-715199) whereas in the updated surface plan as on 31.03.2024, the same is mentioned as 420 mRL. Similarly for top bench at Western side of Pit-1(N-1889223, E-715065) drone data indicates 422 mRL whereas in surface plan it is mentioned 426 mRL, bottom mRL in northern portion of Pit-1 as per drone data is 413 mRL (N-1889221, E-715112 to 1889219, E-715166) whereas in surface plan it is indicated as 420 mRL. |
