विषय/Subject: Violation of provisions of MCDR 2017 in respect of **Taloor** Magnesite mine (ML No.2484) over an extent of 11.88 Ha having Mine code 39KAR14013, in Talooru Village, Mysuru Taluk & District of Karnataka State.

Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 22.06.24 by the undersigned in the presence of Shri Narayana Rao, Agent and Shri Ashok Kumar, Mines Manager/Mining Engineer.

Rules	Nature of Violations observed
45(7) & 11(1)	i) The online Annual return for the year 2023-24 has been submitted by the Lessee. Following discrepancies are noted in the submitted copy as observed during site inspection. Part-V: Para 2. The details of Mineral Resources estimated under 211 of UNFC are not reported correctly as per the last approved document. Para 3. The information has not been furnished in respect of rejects in the table. Para 4. The overburden/waste has been furnished, whereas there is no proposal of generation of OB as per the approved Modified Review and Updation of Mining Plan dated 18.02.2021 there is no proposal of generation of OB.

02. The Mining operations and dispatches may be suspended and any action under subrule (7) of Rule 45 of MCDR 2017 read with MCDR (Amendment), 2021 may be initiated.
03. In this connection, it is again brought to your notice that this violation also constitutes an offence punishable under Rule 62 of MCDR (Amendment), 2021.
04. You are therefore, directed to show cause within a period of thirty (30) days from the date of issue of this notice, as to why action under subrule (7) of Rule 45 and Rule 62 of MCDR 2017 read with MCDR (Amendment), 2021 shall not be taken against you.
05. You are herewith given 30 days time for reply and rectification of the violation from the date of issue of this notice. Please note that no further notice will be given to you in this regard.
