The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 24.06.2024 by the undersigned in the presence of Sri R. Nirmal Kumar, Mines Manager, Sri Gopalkrishna P.S, Geologist.

	The Review and updation of Mining plan was approved by IBM vide letter no.		
	279/302/92/BNG dated 20/01/2023, for the period 2023-24 to 2027-28. The deviations		
	observed in mining operation vis-à-vis approved document are given below:		
	i)It was observed during site inspection that against the proposed Mag		
11 (1) production of 1113 tonnes, the actual production is reported as 260 tonne			
	against the proposed Dunite production of tonnes, the actual production is		
	reported as tonnes during the year 2023-24. The deviation is 77% less		
	production of Magnesite. and the waste of 4209 tonnes has been generated		
	against the proposed waste of 59670 tonnes during the year 2023-24. There is a		
	deviation of 93 % less than the proposed.		
	ii) Against the proposed Dunite production of 278250 tonnes, the actual		
	production is reported as 3694 tonnes during the year 2023-24. The deviation is		
	99% less production.		
	iii)The construction of Retaining wall of 60m, fencing of 60m and Garland drain		
	of 60m has been proposed during the year 2023-24. The same has not been		
	carried out.		

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
