Subject:- Violation of provisions of Mineral Conservation and Development Rules, 2017, in respect of your Vikram Cement Limestone Mine, over an area of 453.423 hectare, situated in village-Nayagaon, Borkedi Tehsil- Jawad, District-Neemuch of Madhya Pradesh State.

Sir,

Undersigned has inspected your mine in the presence of your representative Shri S.C Nigam (Mine Agent) , Shri Sunil Sharma (Mine Manger) and Shri Shailendra kumar Yadav (Geologist) on 20/08/2023. The document of above mentioned mine was approved vide letter No.-MP/Neemuch/Limestone/MPLN/Mod-24/2022-23 dated 29/09/2022 incorporating proposal of working from 2022-23 to 2024-25. Following provisions of MCDR 2017 were found violated in your mines at the time of inspection:

Only 74 tonnes of Limestone production is raised during 2022-23 against the proposed 12,00,000 tonnes. 2. Nil overburden is produced against proposal of 99086 T, thereby distorting the stripping ratio. 3. It was proposed to produce 67559m3 of top soil but Nil top soil is produced. 4. It was proposed to develop 01 pit during the year but no pit was developed. 5. It was proposed to drill 91 boreholes during the year 2022-23 but only 9 boreholes drilled. 6. It was proposed to plant 10,026 saplings during 2022-23 but nil plantation done. |

- In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.
- The mining operations can be suspended under the rule 11(2) of MCDR-2017, if compliance of rule 11(1) of MCDR-2017 is not found satisfactory.
- You are advised to rectify the violations of above mentioned rules immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
