Shri Abhishek Ranjan Gautam, Assistant Mining Engineer inspected your mine on 29/05/2024 in the presence of your representative Shri Varun Grover, and other mines officials. The document of above mentioned mine was approved vide letter No. MP/Katni/Limestone/RMP-24/2021-22 dated 20.07.2021 incorporating proposal of working from 2021-22 to 2025-26. Following provisions of MCDR 2017 (as amended up to 3rd November, 2021) were found violated in your mines at the time of inspection.
